Venue Rental Charges:



- \$5,300 for a one-day event (10 am – 9 pm)
- \$5,500 for a two-day event
 - Friday from 8 a.m. to Saturday at 11 p.m.
- \$6,000 for a three-and-a-half-day event
 - Thursday at 8 a.m. to Sunday at noon rental

Venue Rental Charges (June/September/October):

- \$5,800 for a one-day event
- \$6,000 for a two-day event
- \$6,500 for a three-day event

All packages include – AT NO ADDITIONAL CHARGE:

- Beautiful, handcrafted, **SOLID** wood tables and galvanized steel chairs for up to 150 guests.
 - *Additional guests are charged at \$2.50 per person. Maximum 200.*

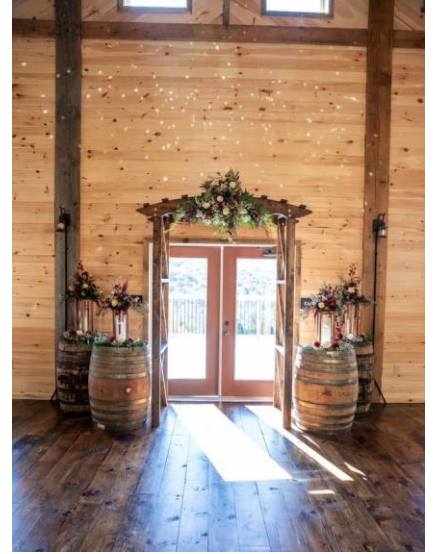

Other Liability Insurance requirements:

- Alcohol – Because we are not affiliated with a winery or brewery, you do not need to purchase alcohol from us. We do, however, REQUIRE that a mobile bartending company with RAMP certified bartenders and liability insurance cover your event. A RAMP CERTIFIED PERSON IS NOT ENOUGH – WHATEVER COMPANY YOU CHOOSE MUST BE ABLE TO PROVE LIABILITY INSURANCE IS IN PLACE or no alcohol will be served.
- Lessee must provide proof of one million-dollar coverage and name **Ray Vernon Estate as an additional insured** on the policy.
